CHICKEN BBQ




LEWIS COUNTY OHV TRAIL SYSTEM

NEW TRAIL

Lewis County OHV Trail System have attained access to the Bald Mountain Area in the Town of Diana and Croghan. The Trail is LIMITED TO 1000 LBS with a registered vehicles. (Due to the seasonal access on NYSDEC Easement property -darker green). This connects the Belfort area to Harrisville near the Harrisville Rod and Gun Club. Lewis County Permits **ARE** required unless you are a member of one of the hunting Clubs on Percival land and have the appropriate Percival sticker. This Trail opens May 1st and closes August 31.
