The expenses were for Rome Humane Society for pet food donation, National Motorsports (ATV club insurance), Rolands Graphics (raffle tickets) and bank service charge. Income came from memberships and a donation from our sponsor Jett Vinyl. A motion was made to accept the report, voted on and passed.

Remember, the profits from the raffle helps to cover the club insurance and the insurance required by the landowner for trails. Expense for this insurance is expected to be \$2900 next year. Without insurance, the club and trail system will be shutdown.

Trail Maintenance-we will be doing trail trimming on July 23 on the Lewis County OHV Trailhead (section G on the Lewis County Trail map) on Fitch Road. Volunteers needed. Contact us.

LC Permit Free Weekend- August 5, 6 and 7. We will set up at Kevin's Tug Hill Hideaway on Fish Creek Road. Volunteers needed.

CLUB FUTURE

At the June meeting, the club's future after the insurance rate increase was discussed. At this point, we do not have the funds to cover the insurance and run the club for 2023. We need to have enough funds at the end of October to go into 2023. The discussions covered:

- 1> All 2022 memberships will expire on Dec 31 as usual.
- 2> There will not be any pre-sale 2023 memberships in 2022.
- 3> 2023 memberships will be suspended until March 2023.
- 4> 2023 memberships will go from \$20 to \$25 for both single and family. Single includes one atv sticker and family includes 2 atv stickers.
- 5> We will sell raffle tickets hoping each member will support this.
- 6> Hold a spaghetti dinner in the fall.
- 7> On August 5-7, the free weekend on Lewis County trails, we will be at the trailhead in front of the Hideaway selling all club merchandise at 10% off including the 2022 Trail maps.
- 8> All charitable donations will be suspended for 2022.

These were all supported by those in attendance and will be voted on at the July meeting.
