I accept and assume all risks and dangers and all responsibility for any such accident or injury no matter how, or by whom, it may be caused. I will ensure my equipment meets New York State safety, insurance, registration, emissions and sound levels  I will not endanger myself and other trail users by riding beyond my ability or while impaired by drugs or alcohol  I will not attempt to disturb or directly pursue wildlife with my recreational vehicle.  I will not construct jumps or obstacles anywhere on the trail or riding areas.  Club membership may be terminated at any time by a vote of the club Board of Directors. Just cause for terminations includes but is not limited to failure to abide by the club member code of ethics.
