<p>I recognize that people will judge all motorized trail users by my actions.</p> <p>I will ride only on designated signed or mapped trails and areas.</p> <p>I will slow down, use caution and be courteous when I encounter other trail users.</p> <p>I will respect and preserve the public and private property that I ride on.</p> <p>I will ensure my equipment meets New York State safety, insurance, registration, emissions and sound levels</p> <p>I will not endanger myself and other trail users by riding beyond my ability or while impaired by drugs or alcohol</p> <p>I will not attempt to disturb or directly pursue wildlife with my recreational vehicle.</p> <p>I will not construct jumps or obstacles anywhere on the trail or riding areas.</p> <p>Club membership may be terminated at any time by a vote of the club Board of Directors. Just cause for terminations includes but is not limited to failure to abide by the club member code of ethics.</p>
